202/24. Reports from external meetings

Strategic Town & Parish Forum - 17th March 25

Attendees from Broughton Parish Council: Hilary Bull, Martin Rose, Robin Shrive

Unfortunately there was no Police attendee, apologies had been received. We then had a brief update on the Big 50 Strategy which just shared again an overview of the project and

announced that they had now elected a Board with parish representation appointed (arbitrarily!) to NCALC.

Two further updates were presented:

- ACRE this was a generic presentation
- NNC Customer experience work that has been ongoing.

It is difficult for NNC to share progress here as not everything that was going on was visible but they are trying to align the various systems across all four legacy bases so that going forward whoever you contact or visit, you should be able to have a unique experience e.g. you could go and pay your Kettering tenancy or council tax in Corby.

The biggest debate was why NNC were not extending the member portal to smaller towns and parishes when there is the capacity to do so.

David Howes was with the room and robust in his challenge as Chair on this point as everyone is having the same poor or non-existent experience. It is something that they will be able to do as the system is cloud based so no capacity issue, it is more a resource issue their end for the time being.

In the meantime, parishes are being urged to use the Strategic Town & Parish email address for any issue or query we have for NNC. We should do this on every occasion so that they are clear on the issues as it was evident from their side that the Head of Customer Service doesn't have any knowledge on all of our woes from our perspective of it being a poor service. Transparency of their information sharing reflecting unnecessary poor customer service was also called in to question by Cllr Shrive especially for the recent budget papers.

Kerry Purnell then went on to brief the forum of the desire to deliver a strategy for devolved or a transfer of service in a managed and sustainable way - it is the directive of the Chief Executive that she is being tasked with this project but the emphasis is for it to happen. Kerry is trying to establish what is in scope or out and will work with everyone to find the best solutions but that nothing will be transferred unless it is wished for. Cllr Bull challenged this with the mandatory devolvement of election costs that came in 18 months ago and then shared our playground equipment and service level agreements situation which prompted a substantial debate across the varied parishes of different experiences and concerns e.g. Mawsley have had equipment taken out by NNC because they wouldn't and didn't have an SLA with them and Rothwell have just submitted a funding bid to Mick George, approved by Dave Lane in which they have agreed that maintenance will be NNC.

Kettering Town Council have confirmed that they do not pay for any play equipment so a Service Level Agreement is a real mess. Kerry announced that some meetings are being organised with the larger towns regarding devolvement and is happy to share outcomes and have some parish representation but understandably is unable to invite all. The first meeting has been issued to some and is on 1st April.

Items for future meetings put forward by Broughton: Neighbourhood Plans & Local Plan and volunteering in the community and how communities are changing.

Meeting cadence will move to Quarterly at the request of the parishes as just two a year is not deemed sufficient.

After the meeting, Cllr Bull emailed Guy Holloway on the subject regarding parish representation on the Big 50 Board and asked for clarification on the appointment of NCALC as parish councils representation and if it has been structured by NNC as a requirement of

their board role because they do not communicate with parishes who have not subscribed to their service.

Guy Holloway replied:

The BIG50 Board is not a North Northamptonshire Council board. It has an independent Chair and I cannot talk on behalf of the Chair or the Board. However, I can help explain the history and decisions leading to its creation.

Before the BIG50 Board was established, there was a steering group made up of a number of different organisations. NCALC was on this steering group along with a number of other partners. NCALC made a very constructive contribution. Independent external advice was sought and it was suggested that NCALC sat on the Board, along with a number of other representatives from organisations across the area.

My understanding is that a number of workstreams have been set up which will help to drive forward delivery of the BIG50 vision for the area.

I am conscious that BIG50 as a strategy covers everyone in the North Northamptonshire area. The aim will, I am sure, be to engage and involve as many people as possible, but in the right way. Regarding NCALC, I am aware that NCALC have made a commitment that they will include all councils, whether they are in their membership or not, when they are ready to engage with councils to feed into the workstream plans they are responsible for. NCALC themselves will be better placed to confirm this with you but Lesley has certainly made that point.

Subject to the decisions made by the Board, I suspect communications channels will be established to keep all stakeholders and interested parties up to speed with developments and to make people aware of the opportunities to get involved. I am sure that this communication will not be reliant on membership of any bodies or organisations.

I will also ensure that I raise your points with the Chair of the BIG50 Board. One of my colleagues will be meeting the chair soon and I will ask that your points are communicated for completeness. END

NNC Public consultation is estimated for next January

NB: BPC will need to know how our existing Neighbourhood Plan will fit in with the new local plan and if the Joint Core Strategy will still be relevant.

206/24. – Traffic calming project – report from working group and NNC Highways

The road priorities for Northampton Road were questioned during a review of the design.

BPC Councillors are meeting Matt Barrett tomorrow for an onsite meeting.

It has been suggested there should be around £35k left to put calming measures in place on Kettering Road

207/24. - High Street Playground Equipment

The clerk emailed Liam Faulkner and requested a letter from NNC to support grant applications or explore a lease agreement.

Julie McKinnin, NNC Principal Community Property Officer replied:

We will consider a lease arrangement; this would be through the Community Asset Transfer process. I am not sure where responsibility currently lies regarding inspection, repairs, and maintenance of the play area, under the lease this would be the Parish Council's responsibility.

We would also consider a letter of support, but North Northamptonshire Council would not take on the responsibility for any new play equipment installed.

The clerk submitted a request to Wicksteed via their website asking if they had any potential interest in Broughton trialling their play equipment

Cllr Scouse contacted Sutcliffes and Proludic to look at their play equipment and quotes which was shared with members. Special focus was given to Proludic;s Active Ninja range, embankment slides and IXO multiplay

The clerk confirmed there is currently £3536.00 in the budget set aside for play equipment. **Action: Clerk to ask Rothwells clerk about their playground.**

The meeting was postponed at 8:10pm to conduct the Annual Electors Meeting and reopened 8:21pm

Comment: Broughton Parish Council believe that extending this licence would have a significantly detrimental impact on the local community, particularly concerning the licensing objective of the prevention of public nuisance.

Our primary concerns are as follows:

- Noise Pollution: A 24-hour operation will inevitably lead to increased noise levels throughout the night. Deliveries, customer traffic, and staff activity will disrupt the peace and quiet that residents of a residential area expect and deserve, especially during sleeping hours. The constant noise will be particularly disruptive to families with young children, shift workers needing rest, and elderly residents. We are concerned about the potential for amplified noise from vehicles, conversations, and potential late-night gatherings outside the premises.
- **Light pollution:** The immediate neighbours are already suffering with the artificial light being emitted from the premises and entering into their property. Artificial light at night can interfere with the body's natural sleep-wake cycle, making it difficult to fall

- asleep or stay asleep. This in turn can lead to health problems and increase depression.
- Anti-Social Behaviour: The granting of a 24-hour licence will likely attract
 individuals engaging in anti-social behaviour, particularly late at night and in the early
 hours of the morning. This could include loitering, public intoxication, and vandalism,
 leading to a decline in the quality of life for residents and a rise in crime in the area.
 The presence of a 24-hour establishment may also encourage increased traffic of
 taxis, motorcycles and other vehicles at all hours, further contributing to noise and
 disturbance.
- Impact on Residential Amenity: The cumulative effect of the noise, anti-social behaviour, and increased traffic will significantly detract from the residential amenity of the area. Residents will no longer be able to enjoy the peace and quiet of their homes. This will negatively impact property values and the overall sense of community.

We believe the above all constitute as statutory nuisances (Environmental Protection Act 1990)

We understand that businesses are an important part of the community, but their operation should not come at the expense of the well-being of residents.

The granting of a 24-hour licence in this residential area is disproportionate and unacceptable. The shop is embedded in a residential street in the centre of the village. It is not in a separate retail zone.

The previous shop held a licence to stay open until 10pm but closed at 9pm, due to lack of footfall.

We urge the Licensing Authority to carefully consider the potential for public nuisance and refuse this application. We believe that granting a licence with more reasonable operating hours would be a more appropriate compromise.
