### 60/25. Minutes to be resolved.

# 61/25. Councillor vacancies and co-option of councillor.

Beverley Davies was co-opted back onto the council again after missing the deadline to sign the Declaration of acceptance of office after the May elections.

Cllr Rose proposed her co-option, seconded by Cllr Shrive. All agreed. Resolved.

Cllr Davies signed the declaration of office and will now fill in the online Register of Interest Form and the election team to be notified.

### 62/25. Public right to speak.

A resident of the High Street spoke about their concerns of over development and increased traffic regarding planning application NK/20242025/0218 and the potential loss of the magnolia tree.

At least 5 people need to submit a comment on an application for it to be decided by the planning committee.

Discussions about the traffic calming project and continuous bad parking around the village. Snap is an operation that allows members of the public to report driving offences in the Northamptonshire area by filling out a form and uploading video evidence. https://snap.northants.police.uk/snap

### 63/25. Reports from NNC ward councillors

No ward councillors were in attendance but Cllr Benneyworth wrote a letter of complaint to the National Grid regarding the significant shortfall in consultation and working practices which have affected the residents in Cransley Hill. National Grid have confirmed they will trellis the substation now the transformer has been replaced and replace fencing to adjacent properties

### 64/25. Report from clerk & correspondence

### **Clerk Report**

The clerk wrote to a number of residents regarding overhanging vegetation after complaints were received by other residents

- Oak Close tree overhanging the footpath
- Wellingborough Road extremely overgrown hedge on the corner of Hutchinson Avenue. Cllr Shrive reported back that the hedge has now been cut back.
- Baker Avenue very large hedge obstructing the junction

The clerk has reported a number of parking issues and traffic offences to the Police after receiving complaints from other road users and residents.

- Corner of Northampton Road and Donaldson Avenue
- Dangerous parking of a van on the corner of Church Street and High Street.
- Abandoned car in West Street As additional information was needed, clerk provided email to report to Police
- Baker Avenue excessive parking near junction
- Excessive speeding in village
- Oak Close Estate car parked entirely on the path

The clerk asked the planning enforcement officer Lorcan Lynch to look into the erection of a new boundary fence on the corner of Wellingborough Road to see if it was lawful and needs planning permission, which at the time of reporting had not been sort. This along with the excessive parking is affecting the visual splay when existing Baker Avenue

Clive Gresham sent the Chair and the clerk a copy of the completed transfer of the lease from Broughton Parish Council to Broughton Playing Field and Village Hall Association CIO

The mass of brambles off Kettering Road encroaching on a neighbour's garden has been deemed a civil matter. Both parties are now aware of problem and solution.

An ex resident of The Gables Farm House and Church Street wrote to the clerk describing her memories of life in Broughton from 1952 - 1970. Cllr Bull responded and is now in contact.

2 Quotes have been acquired for the metal frame of the village map and it was **Resolved** to accept Stately Powder Coating's quote.

- zinc prime and oven baked £70
- top coat and oven baked £70
- collection and delivery £60

Total cost £245 + vat

All agreed a new set of nuts will need to be purchased in addition.

It was agreed to ask Nick Galway to do a provisional quote for the potential new website which could link in with BPC website to include the following:

- Front page with some general historical information
- Doomsday Book, some references to ancient times etc including Little Cransley.
- visuals, coats of arms, image of the Doomsday Book See comment below
- A page with 20th Century Broughton, how it's changed, what shops, farms, pubs, factories etc were in the village.
- QR code per section/page section per QR code, buildings, stories, landscape, etc
- A separate section for recorded stories "Voices from Broughton"?

The clerk will ask about hosting costs

Cllr Rose's brother has translated in the Doomsday book into English. He also has a lot of historic references that could be called upon.

## 70/25. - Traffic calming - Northampton Road and Kettering Road

An onsite meeting was held on 30th June.

Cllr's Scouse, Shrive and Rose met with Matt Barratt from Highways. At the time of the meeting, Matt confirmed that he had been sent the drawings of the planning application in Northampton Rd and he didn't see any conflict with the traffic calming scheme. Matt has drawn up a scheme of road markings for Kettering Rd and confirmed he would email them over, but at the time of the meeting, they had not yet been received. Highways are waiting for a final quote from Balfours who will do the illuminated Give Way signs but they are still aiming for August 18th.

The clerk was asked to check if a TRO had been applied for Kettering Road & Northampton Road for the traffic calming works as it is not advertised yet – **Action: Clerk to email Regulations, Sarah Barnwell and Matt Barrett after meeting.** 

The pollarding of trees took place on the A43 as the roots were under strain and affecting the cycle lane because the trees were now unstable and swaying after unauthorised works were carried out. It was noted to rectify the damage this has caused, will be significant.

#### **71/25.** – Pocket Park

An inspection of the park was carried out. The pond still has water in it although it is low. There were lots of frogs reported. Some areas are overgrown and Cllr Scouse removed some weeds A raised path or board walk would be the best solution for access to the back end of the pond, especially when the dipping platform is under water. The clerk confirmed there is £3500.00 in the budget that includes the member's empowerment fund.
