If a crime is in progress, dial 999

Together we can be on the look out to prevent doorstep crime from happening to someone you know.

What can you do to protect the person you care for?

- Reinforce the message "IF YOU'RE NOT SURE DON'T OPEN THE DOOR".
- Display a 'No Cold Calling Home' sticker to discourage unwanted callers.
- Make the person aware that they are never required to open their door to unexpected callers and that it is not rude to send someone away.
- Explain the tactics used by rogue doorstep traders and distraction burglars. For more information visit www.northants.police.uk/ crimeprevention
- Advise them not to keep money in the house and to keep credit cards, debit cards, cheque books, savings books and any other valuables in a safe place.
- Encourage them to set up passwords with their utility companies.
- Help them ensure that the outside of their property is well maintained.
- If they need any home improvement work carried out, help them to select a Trading Standards approved trader by contacting the 'Buy With Confidence' scheme on 0300 126 1000 or bwc@northamptonshire.gov.uk. Or go to the website www.northamptonshire.gov.uk/ approvedtraders



Help protect the people you care for from falling victim to doorstep crime.

Every day in Northamptonshire people are prone to falling victim to doorstep crime. Most of the victims are elderly or vulnerable.

Whether you are caring for a family member, working as a professional in the community care or community safety field, or just keeping an eye out for a neighbour, you may be the only person that has regular contact with the person(s) you care for and can play a vital role in preventing them from becoming a victim.

Our Doorstep crime Action Network brings together members of the public, private, public, charity, and community sector organisations.

We are asking anyone who has contact with an elderly or vulnerable person to pass on the gentle crime prevention reminders detailed in this leaflet.

Doorstep crime takes two forms:

Distraction Burglary Tactics

Distraction Burglars or 'bogus callers' will call at a house with the intention of tricking their way inside to steal money and/or other valuables.

- Distraction burglars may be smartly dressed and claim to be from the water board, the council, the police, health organisations or charities.
- They may say they need to turn off the water because of a leak, use the phone because their car has broken down, or perhaps say they have lost a pet.
- The caller may be a man, a woman or even a child and they will use any story they can to try and gain access to the property.

Rogue Doorstep Traders' Tactics

Rogue Doorstep Traders will use a trade as a means to extract large sums of money from people.

- Offering services such as driveway re-surfacing, block paving, roofing, fascias, gardening or selling goods such as furniture, alarms or mobility aids.
- They may claim you have a loose roof tile or that a tree you have is unsafe and needs to be trimmed.
- They will often give a very low quote that will increase when work begins.
- Sometimes they will drive victims to the bank and will often come back on future occasions to get more money.
