NNC have received Active Travel England funding to provide cycle parking. Therefore, as part of this consultation there will also be the opportunity for respondents to identify locations where they would wish to see cycle parking provided. **Action: Clerk to write to NNC asking why their cycle paths are never maintained and point out that residents have been clearing the cycle path along the A43.**

A resident emailed the clerk as she is still waiting for a response from the ward councillor and NNC enforcement regarding the erection of the fence at 58 Glebe Avenue. The clerk has responded and sent NNC enforcement another email chasing.

**147/25. Urban Highways Grass cutting**

The clerk went out to tender for 3 cuts to Countrywide Grounds Service, Ground Maintenance Services and E M Pell & Partners who were the only ones to reply and quoted for 3 cuts per year £5606.88 plus VAT

Since NNC wrote to BPC informing they are reducing Broughton's grass cutting from 6 cuts to 3 cuts per year and offering a S136 LGA 1972 grant of only £1130.78, it was **Resolved** that the clerk will write back, refuse the grant and ask NNC to provide the 3 cuts per year. This will be a one year decision only and BPC will reserve the right to make decisions on a yearly basis in the future.

#### **148/25. Report from external meetings**

Cllr Bull attended the launch of The Big50vision held in October. She voiced her concerns that there has obviously been work going on behind the scenes prior to the launch which have included a level of work with the main towns in Northamptonshire. NCALC are on this board and talk of a secondary committee layer will be created for parishes to feed into. The concern is how this secondary committee will be constructed and operate as NCALC is a subscription service of which BPC is not a member and BPC does not want to be excluded from the conversation. **Action: Clerk to write a letter of frustration to the board and also write to NNC Rural Forum as they have still not published the minutes from the meeting in March.**

#### **149/25. Police & Community matters within village**

There was a Knife Amnesty in Broughton on Tue 18 Nov between 15:00 - 16:00 and the Beat Bus was at The Red Lion on 14<sup>th</sup> December. Cllr Shrive attended and reported back that they were giving away a lot of security prevention measures for residents but sadly the surgery was not very well attended.

##### Northamptonshire Police, Fire and Crime Commissioner Consultation

Have your say on police and fire funding Northamptonshire Police, Fire and Crime Commissioner Danielle Stone is asking residents for their views on the council tax precept – the part of your bill that helps fund local policing and fire services. These services rely on a mix of government grants and the precept, which makes up around 18% of a council tax bill. For 2026/27, proposals suggest an increase of:

- £14 a year for policing.
- £5 a year for fire (for a Band D property).

The Commissioner says these changes are needed to balance budgets and invest in vital services.

PCSO Adam Goodes updated the clerk as he had visited the school and moved on a few parents for bad parking. He also had a lovely visit to the nursery kids in Broughton regarding what police do and gave them a little tour of the van.

Unfortunately with the night's drawing in, he has not been able to conduct any speed checks recently but will be looking at their shifts pattern to try and find a better time. **Action: Clerk to email boss to say what a good work he is doing**

Cllr Shrive accepted Northamptonshire OPFCC offer of the “**Crime Prevention in a Box**” scheme which is an initiative designed to strengthen local engagement and promote consistent crime prevention messaging at the village level.

This resource has been developed to assist Parish Liaison Representatives in building stronger, more effective relationships with their communities. It provides standardised crime prevention materials and practical information on community safety to encourage proactive security habits.

There was another incident of ASB/Noise pollution reported EHO reference: ENV774921086 outside Morrisons which took place in the late night hours which are legally defined as 11pm -7am under the noise Act 1996. Cllr Benneyworth wrote to the resident as he is particularly concerned that they have not had a response from the Environmental Health Department yet so will forward onto his colleague, Cllr Kirk Harrison for comment and follow up.

BPC feels it now has enough evidence and will now look into requesting a formal revoke of the licence. **Action: Put on agenda next month**

The map should be positioned centrally from where the map will be placed as this will tie into the original village layout which was a circle including Church Street, Gate Lane and the High Street

As discussed last month 132/25, the website was discussed again and Cllr Davies suggested if the students could be tasked with finding out how easy our current website is to navigate and how much traffic we are generating. **Action: Clerk to get access for Cllr Davies to the website.**

#### **151/25. – Traffic calming – Works update**

Ashleigh Fluegel (Community Liaison Officer for Highways) confirmed the costings for the upcoming priority change works:

- Highways Works: £25,516.33
- Balfour Beatty Works (Jan 2026): £3,472.50
- Total Project Expenditure: £28,988.87

From the original S106 allocation of £83,851.00, a remaining balance of £54,862.13 has been identified.

Matthew Barratt presented a preliminary drawing for a proposed "pinch point" on Kettering Road. Initial estimates place the cost of this project at approximately £71,000.

It was noted that if BPC chooses to proceed with this scheme, they would be required to fund the shortfall (approx. £16,138), as the estimated cost exceeds the remaining S106 balance.

The deadline for utilising the S106 funds is May 2026. As the funding board meets only every two months, the Council must submit a formal proposal immediately to ensure the remaining budget is secured before the expiration date.

It was **Resolved** that BPC will make a contribution so these works can take place but cannot commit to the full asking price. Cllr Scouse has been in correspondence with Cllr Chris McGiffen, to explain the timescale that has ensued with this project and the remaining funds of S106 plus a contribution from BPC would still leave a shortfall of around £4k to achieve the above. His response was positive and he will speak with officers

Cllr Rose has started collecting data from the SID in Northampton Road to compare speed levels before and after the traffic calming works. He presented his findings so far which does show a reduction in speed going out of the village and will present a full report when the data for incoming traffic to the village is available.

The vehicle Activated Sign on Kettering Road is due to be replaced in February so there is an opportunity to place the new sign further up the road subject to confirmation of a suitable power source and consultation with nearby residents.

#### **152/25. – Pytchley Crossroads**

There has been a significant rise in accidents on the Pytchley Crossroads recently, mainly in the evening and morning. Three of these accidents required the Air Ambulance to be in attendance.

**Action: Clerk to ask Pytchley and Orlingborough parishes if they have any data available to see how many drivers are coming from their villages.**  
**Contact Simon Mills from the Road Safety Team and ask for new data to be collected at the crossroads.**

**Write to Highways highlighting the recent accidents and use Cotterstock junction in Oundle Way as an example of another blackspot where works were carried out successfully reducing accidents**

#### **153/25. – Pocket park works**

The Empowerment Fund awarded last May for 1062.94, needs to be spent within 1 year of receipt. Two contractors were asked to quote to raise the rear path on the right side of the pond using compacted layers of rocks, aggregate and soil to keep the area natural while keeping future maintenance to a minimum.

It was **Resolved** to ask Castletree to carry out the works at a cost of £3480.00 plus VAT.

The weeds have built up again in the pond and Cllr Rose offered to carry out these works in due course.
